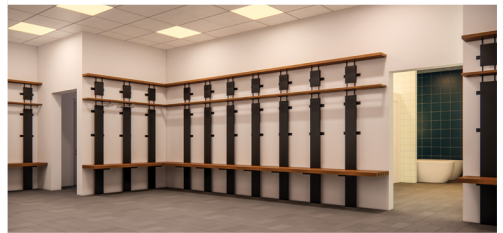

DONATIONS FROM COMPANIES

When a company makes a donation, it is the company that claims the relief. The cost to the company of making the donation is only €875 (€1,000 -€125). The company simply claims a tax deduction on the donation as if it were a trading expense. We can guide you through this process if you require.

MAKE YOUR DONATION GO FURTHER

For individuals or families, under Revenue rules, an approved sports body can claim tax relief on donations made in relation to a project approved by the Department of Transport, Tourism and Sport (DTTAS). When someone paying tax under the PAYE system makes a donation, it is considered to be nett of tax. So, if someone pays tax at 40%, their donation would be considered to be 60% of the donation (similarly, if someone pays tax at 20% their donation is considered as 80% of the donation). In both cases, the club can claim the tax on the donation directly from Revenue, which means your donation goes even further.
